## RETAINED RIGHTS/TERMS AND CONDITIONS

### General

1. Authors/employers retain all proprietary rights in any process, procedure, or article of manufacture described in the Work.
2. Authors/employers may reproduce or authorize others to reproduce the Work, material extracted verbatim from the Work, or derivative works for the author's personal use or for company use, provided that the source and the SMART SOCIETY USA copyright notice are indicated, the copies are not used in any way that implies SMART SOCIETY USA endorsement of a product or service of any employer, and the copies themselves are not offered for sale.
3. In the case of a Work performed under a U.S. Government contract or grant, the SMART SOCIETY USA recognizes that the U.S. Government has royalty-free permission to reproduce all or portions of the Work, and to authorize others to do so, for official U.S. Government purposes only, if the contract/grant so requires.
4. Although authors are permitted to re-use all or portions of the Work in other works, this does not include granting third-party requests for reprinting, republishing, or other types of re-use. The SMART SOCIETY USA Intellectual Property Rights office must handle all such third-party requests.

8. **Electronic Preprints.** Before submitting an article to a SMART SOCIETY USA publication, authors frequently post their manuscripts to their own web site, their employer's site, or to another server that invites constructive comment from colleagues. Upon submission of an article to SMART SOCIETY USA, an author is required to transfer copyright in the article to SMART SOCIETY USA, and the author must update any previously posted version of the article with a prominently displayed SMART SOCIETY USA copyright notice. Upon publication of an article by the SMART SOCIETY USA, the author must replace any previously posted electronic versions of the article with either (1) the full citation to the SMART SOCIETY USA work with a Digital Object Identifier (DOI) or link to the article abstract in SMART SOCIETY USA or (2) the accepted version only (not the SMART SOCIETY USA-published version), including the SMART SOCIETY USA copyright notice and full citation, with a link to the final, published article in SMART SOCIETY USA Journals.
